

DECLARATION OF RESULT

PUNJAB BADMINTION ASSOCIATION ELECTIONS 2025-29

There exists a registered society under the name and style of Punjab Badminton Association H.O. Amritsar since 16/02/1965, now H.O. Ludhiana.

Whereas, in pursuance of the order dated 27/03/2025 passed in CWP/8795 of 2025, Hon'ble Punjab & Haryana High Court was pleased to appoint the undersigned Adhoc Committee for the purpose of conducting the elections of Executive Council of Punjab Badminton Association for the period 2025-29.

That the Adhoc Committee, in pursuance with the directions given by the Hon'ble Punjab & Haryana High Court called upon the District Badminton Association of Punjab to send a list of Authorized Representatives/Delegates to cast votes on 04/05/2025 Nominations were directed to be filed on 30/04/2025 vide separate letter dated 23/04/2025 through e-mail. (Copy of Letter is enclosed herewith) Accordingly, on receipt of the e-mails from respective Districts, a list of Electoral College was prepared on 28/04/2025 separately (Copy of the same is enclosed herewith) the same was displayed on the Public Notice Board of Deputy Commissioner, Ludhiana.

A separate Election Schedule on 23/04/2025 was prepared in consultation with Deputy Commissioner, Ludhiana at his Office. (Copy of Schedule is enclosed herewith). Vide separate authority letter dated 23/04/2025, Deputy Commissioner, Ludhiana was pleased



to appoint Sh. Amarjit Singh Bains, Additional Deputy Commissioner (Dev.), Ludhiana to conduct Elections on his behalf as his authorized Representative. (Copy of the Authority Letter is enclosed herewith)


